



Omanu Swim Club's Code of Conduct

When looking to join the Omanu Swim Club (OSC), the following Code of Conduct must be agreed to before a swimmer is fully registered:

Swimmers are required to adhere to the Code of Conduct. For swimmers under 18, a parent or guardian must agree to the Code of Conduct. Parents/guardians are responsible for ensuring their child adheres to the Code of Conduct.

All Omanu Swim Club Members Are Expected To Demonstrate:

1 Respect and Cooperation

- Be respectful to and cooperate with the Swim Coach and other OSC Management.
- Support other teammates by showing good sportsmanship, pool/lane etiquette, and actively participating in the training sessions.
- Always consider the safety of others.

2 Timeliness and Preparedness

- Be timely and prepared to start your session on time. This includes having the correct swim training gear required, cap and goggles on, and starting the warm-up at the correct time.
- There are times when people are welcome into the pool earlier than the start of a session, but please respect the coach and other OSC members by starting the planned session at the correct start time.

3 Swim Gear and Attire

- Appropriate swimwear is to be worn during training sessions.

- Goggles are to be worn at all levels, during every session.
- Caps are to be worn by all swimmers with hair below eyebrows/ears/collar
(OSC caps are available for \$13.50 each).

4 Pool Area Conduct

- Only be in the pool during your swim session.
- No running, pushing, dunking, or bombing/manu in the pool.
- No swearing.
- No unruly or dangerous behavior anywhere in the water or around the pool.
- No food in and around the pool area.
- No glass in and around the pool area.
- No chewing gum in and around the pool area.
- No hanging out in the changing rooms.

5 Post-Session Requirements

- All Omanu Swim Club members, parents/caregivers must leave the pool area once the last session ends unless they have received permission from the Coach or OSC Management. In this case, the person is responsible for ensuring the pool is properly locked.
- All rubbish and recycling must be taken home or placed in the appropriate bins.

Non-Compliance of Omanu Swim Club Code of Conduct:

- Any OSC member not following the Omanu Swim Club Code of Conduct will be given an initial warning.
 - If non-compliance with the OSC Code of Conduct continues during the session, the swimmer will be asked to leave the pool immediately and stay out for the remainder of the session. If the swimmer is under 18, their parent/caregiver will be informed.
 - If non-compliance with the Code of Conduct continues in a second session, the swimmer will be asked to leave the pool immediately. From

there, a decision will be made regarding the swimmer's future attendance for the remainder of the OSC season.

Note: This decision will involve consultation with the swimmer, a parent/guardian (if under 18), and a representative of OSC management.

Feedback and Contact Information
